- ☞ Date: Saturday, October 7, 2017
- ☞ Show Time: 11 am- 6 p.m.
- ☞ Location ~ North Holliday Street. Check in and set-up 8:30 am- 8:45am. **Must be set -up no later than 10:00 am**
- ☞ Arts & Crafts Vendors are those selling handmade craft items, jewelry, etc.
- ☞ Business & Organization Vendors are those distributing information about their business, church or non-profit organization
- ☞ Outdoor event held Rain or Shine ~ tents are recommended.
- ☞ Participants must provide own tables, chairs & tents. Tents must have weights on the legs.
- ☞ Deadline for application is Monday, September 25, 2017 Applications taken after deadline only on a space available basis.
- ☞ Space Size ~ 10 x 10 (double spaces available ~ a double space is 10 x 20).
- ☞ Cost ~ Arts & Crafts Vendors/Business Vendors ~\$30 per space
(Strasburg Chamber Members-\$20 per space)
- ☞ The Oktoberfest Committee reserves the right to limit the number of vendors selling the same type of products.
- ☞ No electric is available. Only whisper-quiet generators may be allowed.
- ☞ Area **MUST** be left broom clean following the event. Vendors **MUST** remove all trash.
